**FEES STRUCTURE** - All missed classes & private lessons must be paid for. (In the case of an extended holiday of 4 weeks or more, with ample notice the fees will be halved).

All payment of fees must be strictly adhered to. A \$10 Late Fee will apply per week, after week 3 of any term. If accounts are in arrears at the end of each term, classes for the following term may only resume once payment for the previous term has been received.

Siblings will receive a 10% discount if students do at least 2 classes each.

Fees will only be invoiced for term payments. Fees must be paid weekly, fortnightly or at the commencement of each Term:

**WE ARE A REGISTERED COVIDSAFE BUSINESS**

Parents/Grandparents/Carers/Students must ensure they are aware of our COVIDSAFE guidelines & that they be STRICTLY ADHERED TO.

\* RESPECT OUR POLICY - NO PARENTS PERMITTED INSIDE OUR PREMISES.

\* DO NOT send your child if they have any cold or flu symptoms or if they are unwell. Seniors & adults - same applies.

\* DO NOT attend or send your child if they or any of your family have recently visited any Covid-19 Hot Spots (refer to Latest COVID- 19 NSW Government News and Updates).

\* INFORM US IMMEDIATELY if there has been contact with any person testing positive to Covid- 19.

\* Bring/Send personal sanitiser.

\* Bring/Send own water bottles.

\* If possible use bathrooms at home prior to attending class to avoid the use of our communal facilities.

\* Encourage 20 second hand washing rule at all times.

\* Promptness regarding dropping off/picking up students will assist us in an efficient manner of entering and exiting the studio.

\* Inform us if you have changed any of your contact details which we currently have on our files via your enrolment forms.

When students leave the premises they are out of our care. No students should wait outside the premises to be collected. All parents/guardians must wait outside the building until the teacher ushers students out to them.

All students must wear correct uniform at all times. No jewellery, watches or coloured bras are to be worn. NO chewing gum allowed. Bring ONLY water.

All parents & Senior students are responsible for checking their emails at least once a week for updates. It is important to advise of any changes to your enrolment or contact details throughout the year.

All mobile phones must be switched off while inside the dance class. THIS RULE WILL BE ENFORCED!!

If you do not have an email address it is your responsibility to pick up your invoice and newsletter from the front desk.

We also have a face book page which we highly recommend you join.

Any changes to your child's classes must be made prior to the commencement of the Term and by notifying Debbie. If your child wishes to drop a class, please notify Debbie but note the term must still be paid in full.

**CONCERT:** All students require a costume for our end year concert. Parents must be prepared to finance this. Costumes could vary in price from \$55 Baby Dynamites per costume, Sub-juniors per costume \$65, Juniors per costume \$75, Intermediates per costume \$85, and seniors per costume \$95. Concert Costume Fees are Non Refundable.

A rehearsal fee per child is required in term 4 to cover costs involved with concert rehearsals.

As our End of Year Concert is an important event to all students, we expect that at the commencement of Term 3, a commitment is given to stay on until the end of the year...this prevents the whole groups hard work going to waste. Please note all students are required to attend both Dress Rehearsal & Stage Rehearsal. All concert costumes will be ordered in term 3.

**BEHAVIOUR** - All students & parents must behave in a respectable manner towards all staff members of Debbie Rae Dancers inside the studio & out. Any kind of rude or disrespectful behaviour will not be tolerated & will result in the immediate expulsion of the student. We have a ZERO Tolerance bullying policy which includes social media, verbal or physical. Please contact Debbie if you have any concerns re your child's wellbeing during their time with us.

Debbie Rae Dancers will take photographs/video footage for social media, advertising and learning purposes. If for any reason you do not want your child photographed/videoed, please email Debbie. All costumes, routines & choreography are the property of Debbie Rae Dancers, therefore no Parents and/or Students have permission to post on any social media. All choreography remains the property of Debbie Rae Dancers.
